VFCCE PROVIDES STATEWIDE LEADERSHIP IN RAISING FUNDS FOR COMMUNITY COLLEGE STUDENTS,

THANKS TO OUR GENEROUS PARTNERS, THE VFCCE HAS AWARDED MORE THAN \$6 MILLION IN SCHOLARSHIPS, HELPING STUDENTS INCREASE THEIR CHANCES OF SUCCESS. FOR THE 2022 -23 ACADEMIC YEAR, 130 SCHOLARSHIPS WERE AWARDED, TOTALING \$549,400. THE PRESTIGIOUS FELLOWS PROGRAM AWARDS HIGH-ACHIEVING SECOND-YEAR STUDENTS WITH FULL SCHOLARSHIP SUPPORT TO COMPLETE ASSOCIATE DEGREES AND DEVELOP LEADERSHIP SKILLS THROUGH A COHORT MODEL. GREAT EXPECTATIONS STUDENTS HAVE ALMOST TRIPLED THE AVERAGE COLLEGE GRADUATION RATE FOR FOSTER YOUTH, WITH 23% OF GE STUDENTS OBTAINING A COLLEGE CREDENTIAL COMPARED TO ONLY 8% WHO GRADUATE NATIONALLY. ALMOST 1,612 DEGREES, DIPLOMAS, CERTIFICATES, AND CREDENTIALS HAVE BEEN AWARDED TO 933 STUDENTS WHO HAVE EXPERIENCED FOSTER CARE SINCE GREAT EXPECTATIONS' INCEPTION IN 2008.
